IMPORTANT NOTICE: Effective July 1, 2020

Southwest Research Center FCU is updating our **FUNDS AVAILABILITY POLICY** to:

- Increase the amount of funds available on the first business day after a deposit is made in branch or by mail with personal or business checks from \$200 to \$225.
- Increase the amount of funds available from next-day items deposited into new accounts from \$5,000 to \$5,525; and increase the single day check deposit threshold from \$5,000 to \$5,525.
